


RESOLUTION No. 209293

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$117,300.00 by Bill Wilson, an individual, dba Wilco General Engineering Contractors for THE CONSTRUCTION OF GOMPERS NEIGHBORHOOD PARK, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 744980.
2. That the expenditure of \$96,320.00 is hereby authorized out of the Capital Outlay Fund (245), that the expenditure of \$17,000.00 is hereby authorized out of the Gas Tax Fund (220), and that the expenditure of \$16,680.00 is hereby authorized out of the Park Service District Fund (663) Park Ord. No. 11663 of the City of San Diego solely and exclusively for the purpose of providing funds for THE CONSTRUCTION OF GOMPERS NEIGHBORHOOD PARK, in the City of San Diego, and related costs.
