
Adopted on NOV 27 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SAN DIEGO JUNIOR CHAMBER OF COMMERCE, a California nonprofit corporation, for the construction and entry of a float in the annual Tournament of Roses Parade on January 1, 1974, and to administer the allocation of funds granted for the marching band representing the City and County in said Rose Parade, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 745607.

That the expenditure of \$12,000 out of Fiscal 1974 Budget, Special Promotional Programs, Fund 223, is hereby authorized solely and exclusively to provide funds for the services stated above.
