ANNEXATION NO. 1 TO CITY OF SAN DIEGO

All that property in the City of San Diego within the following described boundary:

Beginning at the intersection of the Northerly lines of Federal Boulevard and Mallard Street if extended Westerly as shown on Broadway Heights Unit No. 1, Subdivision Map No 3830 filed in the office of the County Recorder on February 28, 1958; thence N'E'ly along the Northerly line of said Federal Boulevard to the Northwesterly prolongation of the Northerly line of MacArthur Drive as shown on said Map No. 3830 being also the Boundary of the City of San Diego as established by Ordinance No. 7416 adopted on May 5, 1957; thence S'E'ly, E'ly, & N'E'ly along said prolongation and said Northerly line of said Mac Arthur Drive as shown on Broadway Heights Unit No. 2, Map No. 4254, filed in the Office of the County Recorder on July 9, 1959 to the intersection of the N'ly prolongation of the W'ly lot line of Lot No. 17 of said Broadway Heights Unit No. 2; thence S 0° 25' 14" W, 157.65' to the northwest corner of said Lot 17; thence S 52° 01' 41" E, 218.37'; thence N 59° 37' 16" E, 443.31'; thence N 50° 29' 24" E, 547.88'; thence N 68° 41' 51" E, 770.76'; thence N 21° 15' 00" E, 70.00' as shown on Sonka Urban Heights Subdivision Map No. 2351 filed in the office of County Recorder on September 19, 1946; thence N 47° 34' 50" E, 307.36'; thence S 89° 22' 37" E, 30.00'; thence N 0° 37' 23" E, 285.91' to a point on the S'ly line of MacArthur Drive as shown on said Map No. 2351; thence along said S'ly line of MacArthur Drive on a radius of 320. feet through a central arc of 8° 28' 29" a distance of 47.33 feet; thence S 0° 37' 23" W (Ref. S 0° 36' W) along the E'ly line of said Sonka Urban Heights subdivision 240.32 feet; thence S 89° 22' 00" E, 540 feet; thence S 0° 38' 00" W, 379.20 feet; thence N 89° 22' 00" W, 80.00 feet; thence S 0° 38' 00" W 120.00 feet; thence S 89° 22' 00" E, 200.00 feet; thence S 0° 38' 00" W 160.80 feet; thence N 89° 22' 00" W, 150.00 feet; thence S 0° 34' 00" W, 385.00 feet; thence N 89° 00' 00" W, 246.00 feet; thence S 0° 36' 00" W, 304.15' to a point on the S'ly line of Mallard Street (Robinson Street) as shown on map of Highdale Addition to Encanto Heights

Map No. 1176 filed in the office of the County Recorder on April 26, 1909; thence E'ly along said S'ly line of Mallard Street (Robinson Street) to the W'ly line of 69th Street (Front Street) as shown on said Map 1176; thence S'ly along the W'ly line of said 69th Street (Front Street) to the southeasterly corner of Lot 14, Block 5, as shown on Map of Sunny Slope Addition to Encanto Heights Map No. 1135, filed in the office of the County Recorder on June 2, 1908; thence southwesterly along the southeasterly line of Lots 11 through 14, 344.7 ft to a point on the N'E'ly line of Lot 10 of Block 5 of said Sunny Slope Addition; thence southeasterly to the most S'E'ly corner of said Lot 10; thence S'W'ly along the S'E'ly line of said Lot 10 to the E'ly line of Zeller Street as shown on the map of said Sunny Slope Addition; thence in a straight line to the S'E'ly corner of Lot 13, Block 4 of said Sunny Slope Addition; thence S'W'ly in a straight line along the S'E'ly lines of Lots 7 through 13, Block 4, Lots 9 through 14, Block 3, and Lot 24, Block 2, all as shown on said Map 1135, to the S'W'ly corner of said Lot 24, Block 2, Sunny Slope Addition; thence N'W'ly along the S'W'ly line of said Lot 24 to a point on the S'E'ly line of Klauber Avenue as shown on said Map No. 1135; thence in a straight line to the S'E'ly corner of Lot 91 as shown on map of Highdale Addition to Encanto Heights, Map No. 1176, filed in the office of the County Recorder on April 26, 1909; thence N'W'ly along the N'E'ly line of said Lot 91, 160.4 feet to the N'E'ly corner of said Lot 91; thence S'W'ly along the N'W'ly line of said Lot 91, 166.1 feet to the N'W'ly corner of said Lot 91; thence N'W'ly along the N'E'ly line of Lot 19 as shown on the Map of Resubdivision of a portion of Rosemont Addition to Encanto

Heights, Map No. 1240, filed in the office of the County Recorder on March 3, 1910 to a point on the S'E'ly line of Chickadee Drive (East Drive) as shown on said Map 1240; thence in a straight line to the most S'E'ly corner of Lot 15, of said Map 1240; thence S'W'ly along the S'E'ly lines of Lots 10 through 15 to the most S'E'ly corner of Lot 10 of said Map 1240; thence S'W'ly along the S'E'ly lines of Lots 1 through 10 of said Map 1240 to a point on the N'E'ly line of Winnett Street as shown on said Map 1240; thence N'W'ly along the N'E'ly line of Winnett Street as shown on said Map 1240, said Map 1176, Map No. 1193, Del Norte Addition to Encanto Heights filed in the office of the County Recorder on July 9, 1909, and Map No. 2121, Jofaina Vista Subdivision filed in the office of the County Recorder on July 9, 1930, to the N'W'ly corner of Lot 23 of said Map No. 2121; thence N 65° 36' 30" E, 34.88 feet; thence N 55° 43' 30" E, 60.80 feet to the most N'ly corner of Lot 24 of said Map 2121; thence N 89° 03' 30" E, 241.59 feet; thence N 89° 04' 00" E, 59.36 feet to the point of beginning.
