RESOLUTION AMENDING RESOLUTION OF
INTENTION NO. 209135 BY APPROVING PLANS
AND PROFILES SHOWING CHANGES AND

VISTA CHIRP SIDEWALK INSTALLATION PROJECT

said Resolution of Intention; NOW, THEREFORE,

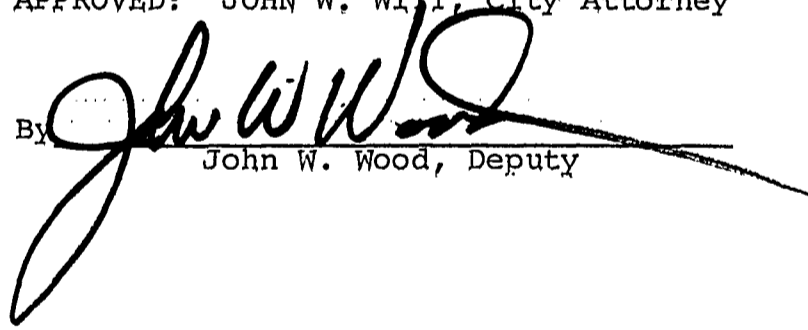
BE IT RESOLVED, by the Council of The City of San Diego,

the same are hereby amended to delete the sidewalk improve-
ments adjacent to Lot 35, Lot 36, Lot 37 and Lot 38 of
Block 4 of Linda Vista Unit No. 7.
