BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, Joint Use Agreements 14979.1, 14978-1 and 14978-2 with the State Department of Transportation for the purpose of transferring the City's present utility easements to a new location to facilitate State maintenance of Freeway 805 between Route 5 in San Ysidro and 3.4 miles north of Route 5, under the terms and conditions set forth in the form of Joint Use Agreements on file in the office of the City Clerk as Document Nos. 745627, 745628, and 745629, respectively.
