1. That the bid of \$30,235.00 by Gaylord F. Arnold, an Individual, dba GFA Electric, for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS at GARNET AVENUE AND JEWELL STREET in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 745064.
2.
