

RESOLUTION NO. 209387 DEC 11 1973

APPROVING MAP OF G-W INDUSTRIAL PARK RESUB

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, and entitled "G-W INDUSTRIAL PARK RESUB Being a Subdivision of Lot 2 of G-W Industrial Park Unit No. 1, according to Map thereof No. 7120, filed in the office of the County Recorder of San Diego County, and a portion of the South Half of the Northwest Quarter of Section 11, Township 15 South, Range 3 West, San Bernardino Meridian, according to United States Government Survey approved February 19, 1883, lying southerly of the southerly line of County Road Survey No. 466, all being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following streets and portion of street: Production Avenue, Camino Santa Fe and a portion of Carroll Road, for public purposes and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and

all abutters' rights of access in and to Camino Santa Fe, adjacent and contiguous to Lots 2, 3 and 4, all as shown on this map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and water facilities as granted on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access and easements for sewer and water, as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
