

RESOLUTION NO. 209398 DEC 11 1973

APPROVING MAP OF VILLA TRINIDAD UNIT NO. 5 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by JOHN M. LEACH, Registered Civil Engineer, and entitled "VILLA TRINIDAD UNIT NO. 5 Being a subdivision of portions of Lots 15, 26, and 27 of Rosedale Tract, according to Map thereof No. 825, filed in the office of the County Recorder, January 21, 1897; and a portion of Lot "D" Referee's Partition Map of a portion of Lot 70, Rancho Mission of San Diego, filed in Superior Court Case No. 15191; all being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following streets: Via Promesa, Promesa Drive, Promesa Court, Promesa Circle, Seda Drive, Seda Cove, Seda Place, Via Palabra, Palabra Circle, Palabra Court, Calle De Vida, Terraza Circle, Terraza Court, Via Carroza, Carroza Court, Pabellon Circle, Pabellon Court, Zorita Court, Zagala Court, Rueda Drive, Vivaracho Way, Via Temprano, and Temprano Court, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters rights of access in and to Clairemont Mesa Boulevard, adjacent and contiguous to Lots 395 through 399, 404, 752, 764 through 799 and 802 through 807, all as shown on this map within this subdivision; together with the open space easements over all of Lots 404, 455, 456, 708, and 752, all as shown on this map within this subdivision and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities and the open space easements as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
