RESOLUTION ADOPTING PLANS AND SPECIFICATIONS FOR THE IMPROVEMENT OF THE ALLEYS IN BLOCK 11, SECOND FORTUNA PARK ADDITION; BLOCK 65, MORENA; AND BLOCK 12, BIRD ROCK ADDITION, ALSO FOR THE CONSTRUCTION OF SIDEWALKS AND OTHER IMPROVEMENTS IN TURQUOISE STREET, FANUEL STREET TO MISSION BOULEVARD, AND ROSECRANS STREET, QUIMBY STREET TO DUMAS STREET.

BE IT RESOLVED, by the Council of The City of San Diego, that the plans, drawings, typical cross-sections, profiles and specifications submitted by the City Engineer and filed in the office of the City Clerk on DEC 10 1973 under Document No. 745725, for:

The improvement of the ALLEYS in BLOCK 11, SECOND FORTUNA PARK ADDITION; BLOCK 65, MORENA; and BLOCK 12, BIRD ROCK ADDITION, also for the construction of sidewalks and other improvements in TURQUOISE STREET, Fanuel Street to Mission Boulevard, and ROSECRANS STREET, Quimby Street to Dumas Street be, and the same are hereby approved and adopted as the official plans, drawings, typical cross-sections, profiles and specifications for said work and improvement.

BE IT FURTHER RESOLVED, that Plat No. 3864, showing the exterior boundaries of the district to be included in the assessment for the work and improvement upon the streets hereinabove mentioned, be, and the same is hereby approved.
