of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 745778, to THE OWNER IN FEE SIMPLE OF RECORD of a portion of Pueblo Lot 256 of the Pueblo Lands of San Diego, effecting the revestment of those abutter's rights of access in and to West Morena Boulevard of said Pueblo Lot 256, heretofore relinquished to the City, more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed to the Property Director of said City for further handling.
