

RESOLUTION NO. 209415 DEC 11 1973

WHEREAS, since the early 1920's, the Fraternal Order of Eagles, San Diego Aerie 244, has encouraged its members to purchase burial lots in Division 8 of Mt. Hope Cemetery and has marked this area with a special monument; and

WHEREAS, the section is not exclusively reserved for the Eagles and only about 200 saleable lots remain; and

WHEREAS, the Council of The City of San Diego has set a schedule of fees for facilities and services of Mt. Hope Cemetery by Ordinance No. 9747 (New Series), adopted January 11, 1968; and

WHEREAS, the Fraternal Order of Eagles Aerie 244, a nonprofit corporation, has indicated a desire to purchase 100 lots in five annual increments of 20 lots per year; and


WHEREAS, the savings to the City in processing costs and the benefits accruing from a group involvement justifies a discounted price of \$165 per lot which is \$35 below the presently approved price; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized to sell to the Fraternal Order of Eagles Aerie 244, up to one hundred (100) Mt. Hope Cemetery burial lots within Section 1, Division 8 of the

cemetery for the sum of \$165 each within the next five year period
or less with a minimum of twenty lots to be purchased per year.
