APPROVING MAP OF MONTEZUMA TOWNHOUSE SUBDIVISION

NOTHOMB, Licensed Land Surveyor, and entitled "MONTEZUMA TOWNHOUSE Being a subdivision of portions of Lots 30, 31, 32, A and B of La Mesa Colony, according to the Map thereof No. 346, filed in the office of the Recorder of San Diego County, March 8, 1887, together with that portion of Reservoir Drive as vacated and closed to public use, in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following streets and portion of street: Reservoir Drive, Reservoir Court, Reservoir Lane, and a portion of Mohawk Street for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in paragraphs 1 and 2 of the certificate signed by the Owners for: sewer, water and drainage facilities, and open space; as granted and shown on said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets and portion of street are accepted on behalf of the public as heretofore stated; and those easements listed in paragraphs 1 and 2 of the certificate signed by the Owners are accepted on behalf of The City of San Diego, a municipal corporation, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
