

RESOLUTION No. 209427


Adopted on DEC 11 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of RESERVOIR PROPERTIES, a limited partnership, executed in favor of The City of San Diego, bearing date of May 21, 1973, conveying to said City an easement and right of way for street purposes and incidents thereto, over, under, upon, along and across a portion of Lot 1 of Campus Palisades, according to Map thereof No. 5716, filed in the office of the County Recorder April 18, 1966, and a portion of Lot 26, La Mesa Colony, according to Map thereof No. 346, filed in the office of the County Recorder March 8, 1887, together with a portion of the Westerly Half of Reservoir Drive, adjoining said Lot 26, La Mesa Colony, on the East, as vacated and closed to public use by Board of County Supervisors, Book of Minutes 43, Page 228, October 18, 1920, as more particularly described in said deed, be and the same is hereby approved and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named RESERVOIR DRIVE.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the County Recorder of San Diego County.
