

RESOLUTION NO. 209446

ADOPTED ON DEC 13 1973

BE IT RESOLVED by the Council of the City of San Diego as follows:

1. That all bids theretofore received on August 28, 1973, pursuant to publication of notice calling for bids on CONSTRUCTION OF LOGAN AVENUE YOUTH CENTER AND BAY BRIDGE (CHICANO) PARK are hereby rejected; and
2. That the Environmental Impact Reports No. 73-1-005C, No. 73-1-006C dated April 11, 1973 and amended on November 16, 1973, and Report #73-11-005C for which the appeal expiration date is 12-11-73, filed in the office of the City Clerk be and the same are hereby adopted.
3. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF LOGAN AVENUE YOUTH CENTER AND BAY BRIDGE (CHICANO) PARK, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California on DEC 7 1973, and bearing official Document No. 745680 be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Council has ascertained the current or prevailing rate of per diem wages paid by private employers in the City for each craft or type of workman or mechanic needed to execute the contract, and does hereby declare that the wage scale included in said specifications is the said current or prevailing rate for the various crafts therein mentioned.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
