

That the bid of \$189,891.00 by Kenneth Fraser Company, Inc., a corporation for INSTALLATION OF 4TH PUMP AT METRO PUMP STATION NO.1 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No.744761.
2. That the expenditure of \$211,500.00 is hereby authorized out of Sewer Revenue Fund (Fund No.506) of the City of San Diego solely and exclusively for the purpose of providing funds for INSTALLATION OF 4TH PUMP AT METRO PUMP STATION NO.1 in the City of San Diego and related costs.
3. That the Environmental Impact Report No. 72-11-004C dated February 1, 1973, filed in the office of the City Clerk be and the same is hereby adopted.
