BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$324,730.00 by M.P. Mitrovich, an individual, for CONSTRUCTION OF BEECH STREET AND G STREET INTERCEPTOR SEWERS, Schedule III, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 745066.
2. That the expenditure of \$370,000.00 is hereby authorized out of Sewer Revenue Fund (Fund No. 506) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF BEECH STREET AND G STREET INTERCEPTOR SEWERS in the City of San Diego and related costs.
3. That the City Auditor be authorized to transfer \$38,000.00 within the Sewer Revenue Fund (Fund No. 506) from the Unallocated Reserve (68.91-3495) to Construction Contract (68.58-3275) for this purpose.
4. That the Environmental Impact Reports Nos. 72-12-002C dated 2/26/73 and 72-12-003C dated 2/23/73 filed in the office of the City Clerk be and the same are hereby adopted.
