

RESOLUTION NO. 209476 DEC 18 1973

WHEREAS, Section 1930 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, a portion of Paseo Montril has been relocated by the approval on this date of a new alignment for Paseo Montril, by the acceptance of the final map of the subdivision to be known as Penasquitos View Unit No. 7; and

WHEREAS, those properties adjoining that portion of Paseo Montril to be vacated will continue to have access or will be accessible by the street which has been dedicated with the approval on this date of the aforementioned subdivision; and

WHEREAS, this Council has determined that the social and economic benefits to be gained by this project outweigh any significant environmental effects which would occur; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Paseo Montril between Rancho Penasquitos Boulevard and Lots 454 and 464, Penasquitos View unit No. 4, as more particularly shown on Drawing No. 13060-B on file in the office of the City Clerk as Document No. 745843, which said drawing is attached hereto and made a part hereof, be and the same is hereby ordered vacated.

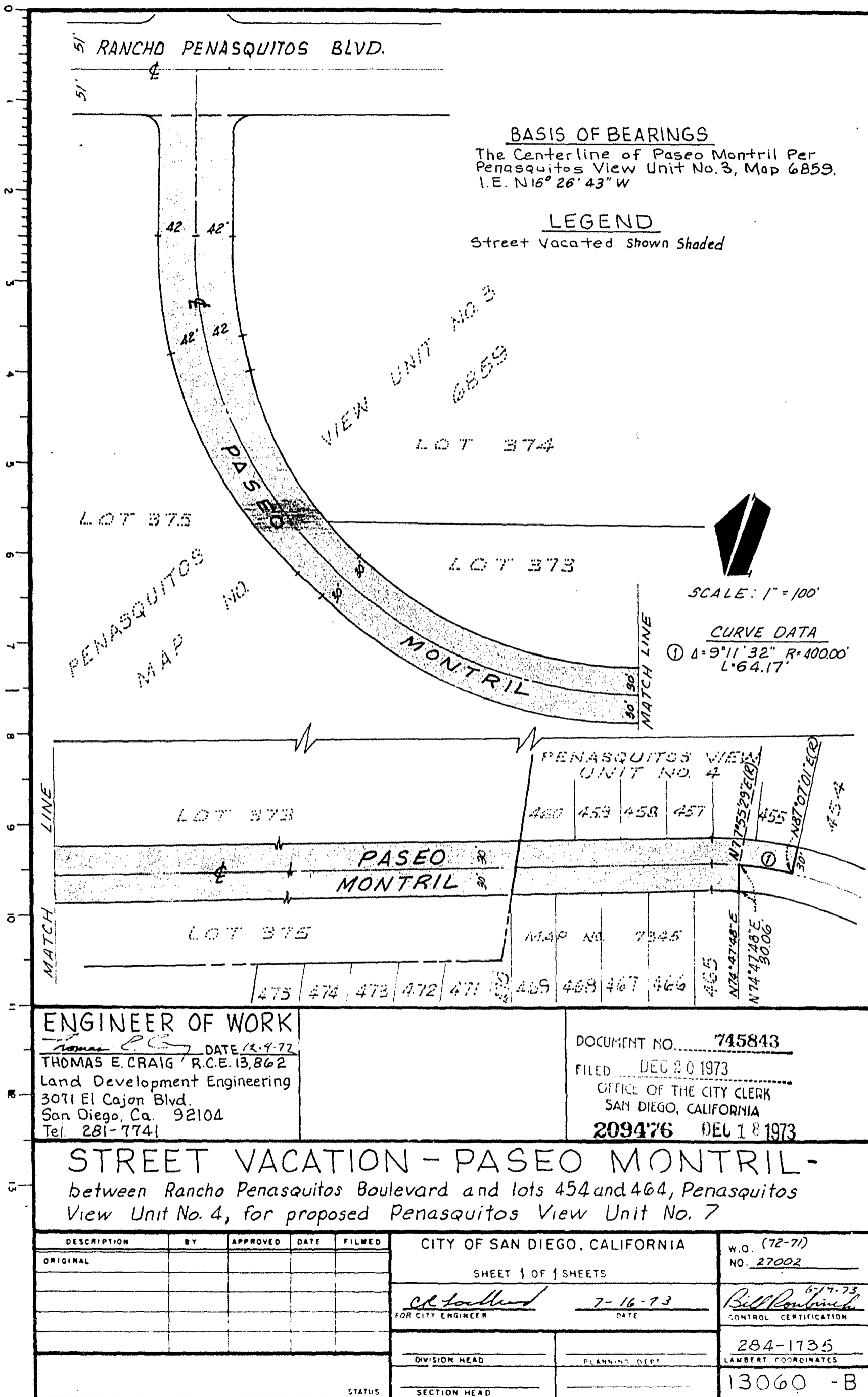
2. That the Environmental Impact Report, No. 73-1-1056P, dated February 28, 1973, filed in the office of the City Clerk be and the same is hereby adopted.
