

RESOLUTION NO. 209483 DEC 18 1973

WHEREAS, in 1964, in connection with the improvement of Poway Road, the City and County entered into an agreement, on file in the office of the City Clerk as Document No. 669853, the purpose of which agreement was to establish the respective responsibilities for the acquisition of right of way and construction; and

WHEREAS, it was determined that each entity would acquire and pay for the necessary rights of way within the areas under their respective political jurisdiction; and

WHEREAS, although certain parcels of right of way were within the City limits, the County proceeded to acquire them in 1966 because it was already at work on acquisition of project right of way within unincorporated territory; and

WHEREAS, the County has relinquished to the City that right of way within the City limits, through adoption of a resolution pursuant to California Streets and Highways Code Section 1704, and is now requesting reimbursement of right of way costs in the amount of \$10,926.06; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the expenditure of \$10,926.06 from Gas Tax Fund 220 be, and the same is hereby authorized solely and exclusively for the purpose of reimbursing the County for its costs of acquiring the above identified right of way within the City for Poway Road Phase II.
