

RESOLUTION NO. 209484 DEC 18 1973

WHEREAS, land to be used for the proposed 15 acre San Ysidro Sports Park (Larsen Field) is under the jurisdiction of the Water Utilities Department; and

WHEREAS, the land is surplus to the needs of the Water Utilities Department and is being transferred to the Park and Recreation Department for development of a recreation field consisting of baseball, soccer, softball and football fields, a small recreation center and a family picnic area; and

WHEREAS, in order to comply with the Waterworks Revenue Bond covenants requiring reimbursement for use of Water Utility assets and services, the Water Utilities Department will receive an annual rent of \$4,100, which has been determined by staff appraisal to be the fair consideration for use of the property; and

WHEREAS, this amount is included in the Recreation Division Budget for Fiscal Year 1974; and

WHEREAS, the major portion of this development will be funded from the Legacy of Parks Open Space Program Grant; and

WHEREAS, this Council has determined that the social and economic benefits to be gained by this project outweigh any significant environmental effects which would occur; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the use and occupancy by the Park and Recreation Department of Water Utilities Department Acre Lots 1, 2 and 3, Tia Juana City (subdivision) for park purposes; be and the same is hereby approved.

BE IT FURTHER RESOLVED, that during such times that a park is operated on this land, the General Fund 100 shall, subject to the allocation of funds, pay the sum of \$4,100 annually to the Water Utilities Fund 500.

BE IT FURTHER RESOLVED, that the Environmental Impact Report, No. 72-12-013C, dated December 7, 1972, filed in the office of the City Clerk be and the same is hereby adopted.
