BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller is hereby authorized to transfer \$28,100 within General Fund 100 from the Unallocated Reserve (53.30) to Public Works Fund 100 (35.06), and that the expenditure of said funds is hereby authorized, solely and exclusively for the purpose of providing funds for the conversion of parking meters by City forces.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City forces all necessary work in conjunction with the conversion of parking meters, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City forces than if let by contract.
