2. That the expenditure of \$14,700.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF SAFETY LIGHTING SYSTEMS ON ROSECRANS BETWEEN RODGERS STREET AND CANON STREET in the City of San Diego and related costs.
