BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$650,000.00, including options and sales tax, by Motorola Communications and Electronics, Inc. for the purpose of UPGRADING THE POLICE COMMUNICATIONS FACILITY AND RELOCATION TO THE CITY OPERATIONS BUILDING in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor.
2. That the expenditure of \$281,000.00 is hereby authorized out of the Revenue Sharing Fund (2381) and that the expenditure of \$369,000.00 is hereby authorized out of the Revenue Sharing Fund (2383) of the City of San Diego solely and exclusively for the purpose of UPGRADING THE POLICE COMMUNICATIONS FACILITY AND RELOCATION TO THE CITY OPERATIONS BUILDING in the City of San Diego, and related costs.
