

RESOLUTION NO. 209516 DEC 20 1973

WHEREAS, a growing number of concerned citizens in San Diego are demonstrating greater ecological awareness by purchasing live Christmas trees; and

WHEREAS, the San Diego Ecology Centre is actively encouraging this program; and

WHEREAS, the Centre is urging citizens to replant the trees following the holidays, thus conserving a natural resource and at the same time beautifying the City of San Diego; and

WHEREAS, the San Diego Ecology Centre is working with the San Diego Girl Scout Council to accept live trees for replanting on youth campsites in the Cuyamaca Mountains; and

WHEREAS, the Centre is working with the City of San Diego to operate three collection sites for conversion of cut Christmas trees to be converted to mulch after the holidays, said mulch to be used in City parks; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that this Council urges all citizens to assist the San Diego Ecology Centre, the Girl Scouts, the City, and other groups, in their efforts to improve our environment and the quality of life in San Diego by purchasing live Christmas trees and by donating the trees for replanting on youth campsites in the Cuyamaca Mountains after the holidays.
