


**RESOLUTION No. 209518**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$276,960.00 by George Taylor Construction Company, a partnership, for CONSTRUCTION OF KEARNY MESA PARK RECREATION BUILDING in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 745207.
2. That the expenditure of \$266,000.00 is hereby authorized out of Park Bond Fund (Fund No. 725); that the expenditure of \$12,100.00 is hereby authorized out of Park Service District Fund (Fund No. 11430); and that the expenditure of \$35,900.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF KEARNY MESA PARK RECREATION BUILDING in the City of San Diego and related costs.
3. That the Environmental Impact Report No. 73-4-005C dated June 8, 1973, filed in the office of the City Clerk be and the same is hereby adopted.
