BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$248,105.00 by Larry Montoya, an Individual, dba Larry Montoya & Sons, for CONSTRUCTION OF PARADISE HILLS PARK & RECREATION CENTER - RECREATION BUILDING in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No.745208.
2. That the expenditure of \$266,000.00 is hereby authorized out of Park & Recreation Bond Fund (Fund No. 725); that the expenditure of \$7,000.00 is hereby authorized out of Capital Outlay Fund (Fund No.245) Reserve; and that the expenditure of \$12,000.00 is hereby authorized out of Park District Fund (Fund No. 11710) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF PARADISE HILLS PARK & RECREATION CENTER - RECREATION BUILDING in the City of San Diego, and related costs.
3. That the Environmental Impact Report No. 73-1-003C, dated February 21, 1973, filed in the office of the City Clerk be and the same is hereby adopted.
