
Adopted on DEC 27 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$31,000.00 by DBX, INC. dba PERRY ELECTRIC, a corporation, for CONSTRUCTION OF TRAFFIC SIGNAL AT FRIARS ROAD AND FRIARS MOBILEHOME PARK ENTRANCE ROAD in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the specifications on file in the office of the City Clerk as Document No. 745290.
2. That the expenditure of \$19,000.00 is hereby authorized out of Gas Tax Fund (Fund No. 220) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNAL AT FRIARS ROAD AND FRIARS MOBILEHOME PARK ENTRANCE ROAD in the City of San Diego, as the City's share of the project and related costs.
3. That the contribution of \$19,000.00 from Fagerheim Dairy, Inc. (Ohre Brothers) to be used for CONSTRUCTION OF TRAFFIC SIGNAL AT FRIARS ROAD AND FRIARS MOBILEHOME PARK ENTRANCE ROAD in the City of San Diego is hereby accepted.
