

RESOLUTION No. 209539


Adopted on DEC 27 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of UNITED STATES OF AMERICA, acting by and through the Department of the Navy, executed in favor of The City of San Diego, bearing date of October 3, 1973, conveying to said City for street and drain purposes, a portion of Section 6, Township 15 South, Range 2 West, together with portions of Sections 1, 11 and 12, Township 15 South, Range 3 West, San Bernardino Base and Meridian, as more particularly described in said deed, be and the same is hereby approved, and the land therein conveyed as Parcel 1 be and the same is hereby dedicated as and for a public street and the same is hereby named MIRAMAR ROAD.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the County Recorder of San Diego County.
