2. Reallocate funds previously authorized for the San Diego Regional Summer Youth Program in City Council Resolution No. 208259 as indicated below:

a. Reallocate PEP funds for use as follows:

- (1) City of San Diego PEP - \$ 94,200
- (2) County of San Diego PEP - \$251,760

b. Reallocate General Revenue Sharing funds and interest thereon as follows:

(1) Accelerated acquisition of
Centre City properties \$175,000

(2) Funding certain critical jobs
in the following City departments:

- (a) Police Department \$ 5,940
- (b) Public Works, Building
Division 44,420
