BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


That the expenditure of \$2,970,009.00 from the Capital Outlay Fund 245 and \$175,000.00 from the Federal Revenue Sharing Fund 2381 for transfer to the Community Concourse Acquisition Fund 259 is hereby authorized solely and exclusively to provide funds for the 1973-74 lease payments to the San Diego City Employees Retirement System in the amount of \$1,423,018.00; and \$1,706,456.24 toward the purchase of portions of Blocks I, 13 and 51 of Horton's Addition and to provide \$15,534.76 as a reserve for future commitments, as follows:

C. Convention Hall	414,244.00
D. Exhibit Hall-Garage	201,336.00
E. Land Rental Payment	<u>139,140.00</u>

Reserve for Future Commitments	<u>15,534.76</u>

BE IT FURTHER RESOLVED, that the acceptance by the City Manager of that deed of BOARD OF ADMINISTRATION, THE SAN DIEGO CITY EMPLOYEES' RETIREMENT SYSTEM, executed in favor of The City

of San Diego, bearing date of November 28, 1973, conveying to said City portions of Blocks I, 13 and 51, as more particularly described in said deed, valued at \$500.00 or more as certified by the Property Director of said City, be and the same is hereby approved.
