ORDINANCE NO. 11224 JAN 24 1974

AN ORDINANCE INCORPORATING ALL C ZONED PROPERTY BOUNDED ON THE WEST BY LA JOLLA HERMOSA AVENUE, ON THE SOUTH BY LA CANADA, ON THE EAST BY ELECTRIC AVENUE AND FAY AVENUE, AND ON THE NORTH BY THE SOUTHERLY BOUNDARY OF RECORD OF SURVEY 1033, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A AND CO ZONES, AS DEFINED BY SECTIONS 101.0410 AND 101.0423, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13294, APPROVED AUGUST 31, 1931, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 2. That Ordinance No. 13294, approved August 31, 1931, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.
