AN ORDINANCE AMENDING ORDINANCE NO. 11108 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1973-74 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING SECTION 2, SUBSECTIONS 1 AND 7 THEREOF, RELATING TO ALLOCATION OF FUNDS BY TRANSFERRING FUNDS FROM GENERAL REVENUE SHARING FUNDS TO POLICE DEPARTMENT 15.00, PERSONAL SERVICES.

WHEREAS, the Council of The City of San Diego has established an Educational Incentive Program for all sworn personnel in the San Diego Police Department; and

WHEREAS, funds for such program were originally set aside in the CIP Reserve; and

WHEREAS, it is now necessary to transfer funds from General Revenue Sharing to the Police Department, Department 15.00, Personal Services, for the purpose of funding said program; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11108 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1973-74 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Section 2, subsections 1 and 7 thereof, relating to the allocation of funds by transferring the sum of
