AN ORDINANCE INCORPORATING ALL THAT PROPERTY IN THE MIDDLETOWN AREA, GENERALLY BOUNDED BY WASHINGTON STREET ON THE NORTH, PUTERBAUGH, GUY AND UNION STREETS ON THE EAST, VINE STREET ON THE SOUTH, AND INDIA STREET ON THE WEST, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12990, APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That all that property in the Middletown Area, generally bounded by Washington Street on the north, Puterbaugh, Guy and Union Streets on the east, Vine Street on the south, and India Street on the west, in the City of San Diego, California, within the boundary of the district shown as Area A and designated "R-2A" on Zone Map Drawing No. C-388.6, filed in the office of the City Clerk as Document No. 746158, be, and it is hereby incorporated into R-2A Zone as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12990, approved October 20, 1930 of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
