ORDINANCE NO. FEB. 7 1974 (New Series)

AN ORDINANCE INCORPORATING LOTS 3-7, G-W INDUSTRIAL PARK NO. 2, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B ZONE AS DEFINED BY SECTION 101.0435.2 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10446 (NEW SERIES), ADOPTED DECEMBER 1, 1970, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 3-7, G-W Industrial Park No. 2, in the City of San Diego, California, within the boundary of the district designated "M-1B" on Zone Map Drawing No. B-2753, filed in the office of the City Clerk under Document No. 745481 be, and they are hereby incorporated into M-1B Zone, as such zone is described and defined by Section 101.0435.2 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10446 (New Series), adopted December 1, 1970, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
