AN ORDINANCE AMENDING CHAPTER II, ARTICLE 4,
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING
SECTION 24.0509 RELATING TO DISABILITY
RETIREMENT.

BE IT ORDAINED, by the Council of The City of San Diego
as follows:

Section 1. That Chapter II, Article 4, of the San Diego
Municipal Code be, and the same is hereby amended by amending
Section 24.0509 to read as follows:

SEC. 24.0509

The Board of Administration shall prescribe
rules and regulations for an annual filing of an
affidavit of condition of disability from any
member, including a safety member, who has been
retired for disability, industrial or nonindustrial.
The Board may at any time prior to the time such
member reaches the minimum age for voluntary retire-
ment order suspension of benefits for failure to
timely submit such affidavits or for failure to
comply with any lawful order of the Board.

Section 2. This ordinance shall take effect and be in force
on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING CHAPTER II, ARTICLE 4, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 24.0500 RELATING TO DISABILITY RETIREMENT. BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 4, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 24.0500 to read as follows:

SEC. 24.0500

The Board of Administration shall prescribe rules and regulations for an annual filing of an affidavit of condition of disability from any member, including a safety member, who has been retired for disability, industrial or nonindustrial. The Board may at any time prior to the time such member reaches the minimum age for voluntary retirement order suspension of benefits for failure to timely submit such affidavits or for failure to comply with any lawful order of the Board.
