ORDINANCE NO. 11237 FEB 1 4 1974 (New Series)

AN ORDINANCE INCORPORATING ALL THAT PROPERTY IN THE MIDDLETOWN AREA, GENERALLY BOUNDED BY VINE STREET ON THE NORTH, UNION STREET AND HORTON AVENUE ON THE EAST, SASSAFRAS STREET ON THE SOUTH, AND INDIA STREET ON THE WEST, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12987 AND ORDINANCE NO. 12990, BOTH APPROVED OCTOBER 20, 1930 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That all that property in the Middletown Area, generally bounded by Vine Street on the north, Union Street and Horton Avenue on the east, Sassafras Street on the south, and India Street on the west, in the City of San Diego, California, within the boundary of the district shown as Area B and designated "R-3A" on Zone Map Drawing No. C-388.7, filed in the office of the City Clerk as Document No. 746159, be, and it is hereby incorporated into R-3A Zone, as such zone is described and defined by Section 101.0412, of the San Diego Municipal Code.

Section 2. That Ordinance No. 12987 and Ordinance No. 12990, both approved October 20, 1930 of the Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith.
