ORDINANCE NO. 11239 FEB 21 1974

AN ORDINANCE INCORPORATING ALL THAT PROPERTY IN THE CLAIREMONT AREA LOCATED ALONG CLAIREMONT MESA BOULE-VARD, BETWEEN FRINK AVENUE ON THE WEST AND DOLIVA DRIVE ON THE EAST, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A, R-3 AND R-2 ZONES, AS DEFINED BY SECTIONS 101.0412, 101.0411 AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego. as follows:

Section 1. That all that property in the Clairemont Area located along Clairemont Mesa Boulevard, between Frink Avenue on the west and Doliva Drive on the east, in the City of San Diego, California, within the boundary of the district designated "R-3A," "R-3" and "R-2" on Zone Map Drawing No. C-393.1, filed in the office of the City Clerk as Document No. 746055, be, and it is hereby incorporated into R-3A, R-3 and R-2 Zones, as such zones are described and defined by Sections 101.0412, 101.0411 and 101.0409, respectively, of the San Diego Municipal Code.

Section 2. That the following Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith:
