ORDINANCE NO. 11242 FEB 21 1974

AN ORDINANCE INCORPORATING ALL THAT PROPERTY IN THE CLAIREMONT AREA, CONSISTING OF A PORTION OF LOT 3447, AND LOTS 3395, 3396, 3435, AND 3436, CLAIREMONT TRACT 12, LOCATED IN THE VICINITY OF KAMLOOP AND MORAGA AVENUES, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 AND R-1-5 ZONES, AS DEFINED BY SECTIONS 101.0409 AND 101.0407, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 6504 (NEW SERIES), ADOPTED MAY 12, 1955, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That all that property in the Clairemont Area, consisting of a portion of Lot 3447, and Lots 3395, 3396, 3435, and 3436, Clairemont Tract 12, located in the vicinity of Kamloop and Moraga Avenues, in the City of San Diego, California, within the boundary of the district designated "R-2" and "R-1-5" on Zone Map Drawing No. C-395.1, filed in the office of the City Clerk as Document No. 746051, be, and it is hereby incorporated into R-2 and R-1-5 Zones as such zones are defined by Sections 101.0409 and 101.0407, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 6504 (New Series), adopted May 12, 1955 of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
