ORDINANCE NO. 11245 FEB 21 1974

AN ORDINANCE INCORPORATING ALL THAT PROPERTY IN THE CLAIREMONT AREA, GENERALLY BOUNDED BY MESA COLLEGE DRIVE ON THE SOUTH, ARMSTRONG STREET ON THE WEST, ARMSTRONG PLACE ON THE NORTH AND ASHFORD STREET ON THE EAST, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9418 (NEW SERIES) ADOPTED MAY 12, 1966, ORDINANCE NO. 9010 (NEW SERIES) ADOPTED MAY 7, 1964 AND ORDINANCE NO. 8833 (NEW SERIES) ADOPTED MAY 23, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That all that property in the Clairemont Area, generally bounded by Mesa College Drive on the south, Armstrong Street on the west, Armstrong Place on the north and Ashford Street on the east, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-397.1, filed in the office of the City Clerk as Document No. 746052, be, and it is hereby incorporated into R-3 Zone as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 9418 (New Series), adopted May 12, 1966, Ordinance No. 9010 (New Series), adopted May 7, 1964 and Ordinance No. 8833 (New Series), adopted May 23, 1963 of the Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith.
