

ORDINANCE NO. 11247 FEB 21 1974
(New Series)

AN ORDINANCE INCORPORATING ALL THAT PROPERTY IN THE CLAIREMONT AREA LYING ADJACENT TO AND ON INTERSTATE 5 FROM JUST SOUTH OF ROSEWOOD STREET ON THE NORTH TO THE WESTERLY EXTENSION OF KNOXVILLE STREET ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That all that property in the Clairemont Area, lying adjacent to and on Interstate 5 just south of Rosewood Street on the north to the westerly extension of Knoxville Street on the south, in the City of San Diego, California, within the boundary of the district designated "R-1-5" on Zone Map Drawing No. C-398.2, filed in the office of the City Clerk as Document No. 746344, be, and it is hereby incorporated into R-1-5 Zone as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That the following Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith:
