AN ORDINANCE AMENDING ORDINANCE NO. 11075 (NEW SERIES), AS AMENDED, TO CREATE THE CLASSIFIED POSITION OF NOISE ABATEMENT OFFICER AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:
