AN ORDINANCE INCORPORATING ALL THAT PROPERTY IN THE CLAIREMONT AREA, LOCATED IN THE VICINITY OF JELLETT AND CHICAGO STREETS, BETWEEN INGULF STREET ON THE NORTH AND KANE STREET ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 7697 (NEW SERIES), ADOPTED DECEMBER 19, 1957 OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That all that property in the Clairemont Area, located in the vicinity of Jellett and Chicago Streets, between Ingulf Street on the north and Kane Street on the south, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-398.2, filed in the office of the City Clerk as Document No. 746344, be, and it is hereby incorporated into R-3 Zone as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 7697 (New Series), adopted December 19, 1957 of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
