AN ORDINANCE AMENDING CHAPTER II, ARTICLE 5 OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING DIVISION 1 THEREOF, SECTIONS 25.0101 THROUGH 25.0127, RELATING TO A FIRE DEPARTMENT MERIT SYSTEM.

WHEREAS, Section 58 of the Charter of The City of San Diego provided that members of the Fire Department, after initial appointment, shall not be subject to the Civil Service provisions of the Charter but shall be subject to fixed rules and regulations of a Fire Department Merit System; and

WHEREAS, said fixed rules and regulations were established and codified in Chapter II, Article 5, Division 1 of the San Diego Municipal Code; and

WHEREAS, Proposition H appearing on the September, 1973, ballot proposed that Section 58 of the Charter be amended to place all members of the Fire Department under the Civil Service provisions of the Charter; and

WHEREAS, the electorate voted to approve Proposition H in said election; and

WHEREAS, said Charter change has eliminated any requirement for continuance of a Fire Department Merit System as previously established; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 5 of the San Diego Municipal Code be and the same is hereby amended by repealing Division 1 thereof, Sections 25.0101 through 25.0127.

Section 2. This ordinance shall take effect and be in force on July 1, 1974.
