AN ORDINANCE INCORPORATING LOT 1, BALBOA SHOPPING CENTER; LOTS 1, 2 AND 3, GENESEE PLAZA SUBDIVISION; AND LOTS 5, 6, 8, 9, 12 AND 25, BALBOA SHOPPING CENTER RESUBDIVISION NO. 1, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA-S ZONE, AS DEFINED BY SECTION 101.0428 OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING ORDINANCE NO. 8315 (NEW SERIES), ADOPTED JUNE 16, 1960, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 1, Balboa Shopping Center; Lots 1, 2 and 3, Genesee Plaza Subdivision; and Lots 5, 6, 8, 9, 12 and 25, Balboa Shopping Center Resubdivision No. 1, in the City of San Diego, California, within the boundary of the district designated "CA-S" on Zone Map Drawing No. B-2545, filed in the office of the City Clerk under Document No. 744677 be, and they are hereby incorporated into CA-S Zone, as such zone is described and defined by Section 101.0428 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8315 (New Series), adopted

June 16, 1960 of the Ordinances of The City of San Diego be,

and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
