ORDINANCE NO. 11263 MAR 5 1974

AN ORDINANCE AMENDING CHAPTER II, ARTICLE 4, DIVISION 5-C, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 24.0542 and 24.0543 RELATING TO THE LEGISLATIVE OFFICERS RETIREMENT SYSTEM.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 4, Division 5-C, of the San Diego Municipal Code be, and the same is hereby amended by amending Sections 24.0542 and 24.0543 to read as follows:

SEC. 24.0542

Every legislative officer in office at the time this section becomes effective, or elected after the effective date of this section, may become a member of this System if he files with the Board a written election to become a member. SEC. 24.0543

Every legislative officer who elects to become a member may also elect within one year of becoming a member to receive credit for the service rendered as a legislative officer prior to his becoming a member if he makes contributions to the System equal to the contributions he would have made had he been a member during the period of prior service for which he is electing to receive credit.



Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
