AN ORDINANCE AMENDING ORDINANCE NO. 11108 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1973-74 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 743372, AS ADOPTED AND AMENDED BY DOCUMENT NO. 744013 AND DOCUMENT NO. 744714, TO ADD ONE SUPERVISING ADMINISTRATIVE ANALYST POSITION TO THE POSITION AND SALARY SCHEDULE FOR FUND 100, COUNCIL DISTRICT DEPARTMENT 02.05.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11108 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1973-74 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended to amend that portion of the Position and Salary Schedule for Department 02.05, Fund 100, to reflect and authorize the addition of one Supervising Administrative Analyst position to Council District Department 02.05.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
