AN ORDINANCE INCORPORATING A PORTION OF LOT 1, IMPERIAL HOUSE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10412 (NEW SERIES), ADOPTED SEPTEMBER 24, 1970 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That a portion of Lot 1, Imperial House, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-2765, filed in the office of the City Clerk under Document No. 746190 be, and it is hereby incorporated into CO Zone, as such zone is described and defined by Section 101.0423 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10412 (New Series), adopted September 24, 1970, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
