AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 4, DIVISION 3, OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTIONS 44.0305, 44.0311, 44.0312, 44.0313, 44.0314, 44.0315, 44.0316, 44.0317, 44.0322, 44.0323, 44.0324, 44.0325, 44.0325.1, 44.0326, 44.0327, 44.0328, 44.0328.1, 44.0328.2, 44.0329, 44.0330, 44.0331, 44.0332, 44.0333, 44.0334, 44.0335, 44.0336, 44.0337 AND 44.0338; AND BY ADDING SECTION 44.0300, ALL RELATING TO ANIMAL CONTROL AND REGULATION.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Sections 44.0305, 44.0311, 44.0312, 44.0313, 44.0314, 44.0315, 44.0316, 44.0317, 44.0322, 44.0323, 44.0324, 44.0325, 44.0325.1, 44.0326, 44.0327, 44.0328, 44.0328.1, 44.0328.2, 44.0329, 44.0330, 44.0331, 44.0332, 44.0333, 44.0334, 44.0335, 44.0336, 44.0337 and 44.0338, of Chapter IV, Article 4, Division 3 of the San Diego Municipal Code be and the same are hereby repealed.

Section 2. That Chapter IV, Article 4, Division 3 of the San Diego Municipal Code, be and the same is hereby amended by adding thereto Section 44.0300 to read as follows:

SEC. 44.0300 SAN DIEGO COUNTY ANIMAL CONTROL ORDINANCE -  
ADOPTION BY REFERENCE

The following sections of the County Code of the County of San Diego, California, three copies of which are on file in the office of the City Clerk of The City of San Diego, are hereby adopted as the Animal Control

shall be superseded by the provisions of this Division.

Section 3. Any-person who violates a provision of the San  
Diego County Code as adopted and incorporated hereinabove shall  
be charged with a violation of the applicable section of said  
Code and upon conviction said person shall be punished as  
prescribed by Section 11.12 of the San Diego Municipal Code.

Section 4. This ordinance shall take effect and be in force  
on the thirtieth day from and after its passage.

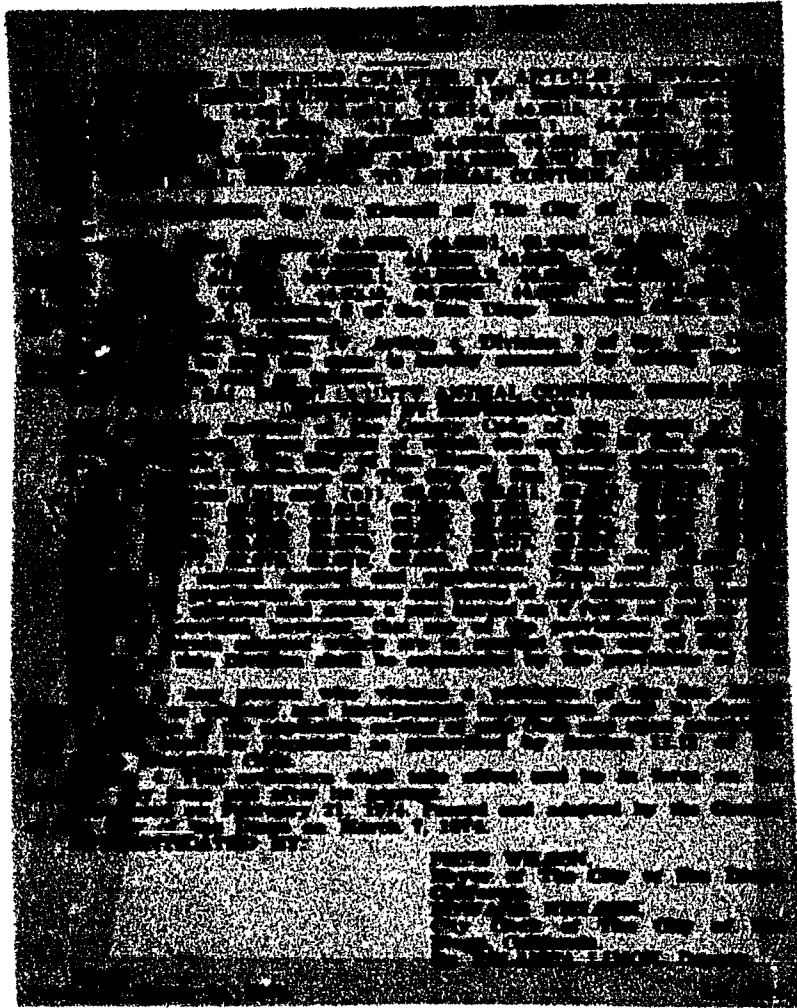
