AN ORDINANCE INCORPORATING PORTIONS OF LOTS 1 AND 2, G-W INDUSTRIAL PARK UNIT 1, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1S ZONE AS DEFINED BY SECTION 101.0430 OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING ORDINANCE NO. 10446 (NEW SERIES), ADOPTED DECEMBER 1, 1970 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Lots 1 and 2, G-W Industrial Park Unit 1, in the City of San Diego, California, within the boundary of the district designated "C-1S" on Zone Map Drawing No. B-2774, filed in the office of the City Clerk under Document No. 746384 be, and they are hereby incorporated into C-1S Zone, as such zone is described and defined by Section 101.0430 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10446 (New Series), adopted December 1, 1970, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
