AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PENINSULA COMMUNITY PLAN LOCATED: ON THE NORTH SIDE OF BANNING STREET AND WEST OF NIMITZ BOULEVARD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A AND R-3 ZONES, AS DEFINED BY SECTIONS 101.0410 AND 101.0411, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 31 (NEW SERIES), ADOPTED SEPTEMBER 6, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 2. That Ordinance No. 31 (New Series), adopted September 6, 1932, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
