AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PENINSULA COMMUNITY PLAN LOCATED IN AN AREA BOUNDED BY TENNYSON STREET, CHATSWORTH BOULEVARD AND NIMITZ BOULEVARD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 ZONE, AS DEFINED BY SEC-TION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 31 (NEW SERIES), ADOPTED SEPTEMBER 6, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Peninsula Community Plan located in an area bounded by Tennyson Street, Chatsworth Boulevard and Nimitz Boulevard, in the City of San Diego, California, within the boundary of the district designated "R-1-5" on Zone Map Drawing C-392.2 , filed in the office of the City Clerk as 746854 , be, and it is hereby incorporated into Document No. R-1-5 Zone as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 31 (New Series), adopted September 6, 1932, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
